In exchange for being able to enter, attend or participate in the event I/we agree:

- To release ANDRA, HVDRA the promoters, sponsor organizations, land owner’s, organizers of the event, their respective servants, meeting director and officials (collectively the “Associated Entities) from all liability for my death, personal injury (including burns), psychological trauma, loss or damage (including property damage) (“harm”) howsoever arising from my participation in or attendance at the event, except to the extent prohibited by law.
